

NOTICE OF PUBLIC HEARINGS  
UTAH TRANSIT AUTHORITY

RE: Route Modifications in Weber, Davis and Salt Lake Counties  
**April 4, 2010 Change Day**

I. Notice is hereby given for public hearings concerning the implementation of April Change Day 2010. The Utah Transit Authority (UTA) is proposing the following modifications of our service:

Davis County (Public Hearing):

- Proposal for complete elimination of express routes 472, 474, and 476.

Weber County (Public Hearing):

- Proposal for complete elimination of express routes 472, 474, and 476.

Salt Lake County (Public Hearing):

- Proposal for complete elimination of routes 522 and 551.
- Proposal for complete elimination of Saturday service on routes 9, 11, and 17.
- Proposal for elimination of the following routes' trips: 307 (4:05 pm and 5:50 pm), 313 (5:37 am and 5:25 pm), 347 (4:17 pm) 348 (3:40 pm), 354 (5:53 am, 4:00 pm and 5:30 pm), 453 (5:47 pm), 461 (6:09 pm).
- Proposal on the elimination and/or reduction in Saturday Service for routes 62, 232, 248, and 228.
- Proposal on the elimination and/or reduction in Sunday Service for routes 39 and 45.
- Proposal of the re-routing of routes 78, 90, 213, 232, 516, 517, 519, 520, 525, and 556.

The recommended changes are being proposed due to budgetary constraints as a result of reduced sales tax revenues.

- III. At the hearing, the Utah Transit Authority will afford an opportunity for affected citizens, public officials and interested agencies to comment on the proposed changes. To be included as part of the public hearing record, all comments must be postmarked no later than five days following the final public hearing or February 1, 2010.
- IV. THE FORMAT FOR THE PUBLIC HEARINGS WILL BE AS FOLLOWS:
  - a. Open House to review and discuss proposal with UTA representatives (entire time)
  - b. Public comment period (available any time during public hearing)
