ANNEXATION - NOW WHAT?

The following information should help answer your immediate questions. Additional, helpful information is available throughout this packet and also on our website: www.nslcity.org.

GARBAGE AND RECYCLING

For all customers within the annexation area that use ACE Recycling and Disposal, the City asks that you complete a City utility application in order to begin City garbage service. If you are with ACE right now, they have agreed to allow you to cancel your ACE account without any fees or penalties. ACE customers can make application any time after February 1, 2023 and will have until December 31, 2023 to sign up for City utilities.

For those customers using A-1 Disposal or another garbage service, you will have until **December 31, 2023** to sign up for City garbage service. By giving residents 12 months to sign up for City utilities, it should allow for City utility sign-up during 2023 at the time when your contracts with other garbage haulers expire. Beginning January 1, 2024, the City will require monthly payment for garbage service and storm drain utility fees and so we encourage residents to not enter into any additional contracts that extend into 2024.

You may also come to the City offices in-person between 7:00 am and 5:30 pm Monday through Thursday beginning February 1, 2023. Regular curbside garbage pickup is weekly and will be on Wednesdays for the new annexation area. Recycling pick up will occur every other week also on Wednesdays. Curbside recycling is not mandatory in North Salt Lake, though

GARBAGE WHAT TO DO:

Transfer Garbage Service to

How?

Already an ACE customer? Simply sign up for a new NSL utility account. We will handle the transition.

Using a different garbage hauler? Terminate contract before Jan. 1, 2024 and sign up for NSL service.

we encourage residents to use a recycling container since it is less expensive than a second garbage container. Garbage rates are \$15.87 per month for each garbage can and \$6.26 per month for each recycling container requested. The City also charges a \$7 per month storm drain fee to operate, maintain and replace storm drain infrastructure, but this fee will not begin until January 1, 2024.

ADDRESSES

The City determined when it approved the resolution to annex that it would form a small group of staff and affected parties to study the question of whether or not to change addresses in the annexation area. Further, the City Council requested that no address changes be made for at least twelve (12) months after annexation. The City is currently gathering information from various public agencies such as the South Davis Metro Fire Agency, the United States Postal Service and the Utah State Tax Commission about address changes. Once that information is assembled, the City will work with the sub-group to formulate a recommendation to the City Council about address changes. Prior to making address changes, if any, the City Council will hold a meeting to consider any recommendations from the sub-group.

ADDRESSES WHAT TO DO:

- No address changes will be required in the immediate future

ZONING & LAND USES

The City of North Salt Lake has not yet determined the City zoning that will be placed on newly-annexed properties. This process will take place in early 2023 and a public hearing will be held to receive input on zoning. The City will make every attempt to establish zoning categories that accommodate existing land uses and which will also be consistent with County zoning. The City does not intend to change the zoning to allow a different land use plan than what exists today in the newly-annexed neighborhood.

ZONING WHAT TO KNOW:

- City will review in 2023 with input from residents and review of existing uses

If there is an existing use that is lawfully permitted today under Davis County's zoning, but may not be permitted in the new City zoning, that land use will become legally non-conforming, sometimes known as being "grandfathered." That means that the land use may continue to exist as long as it is not abandoned for more than a year. Please note that if you are conducting a land use that is prohibited under County zoning, that use may also be prohibited under City zoning and may be subject to

code enforcement action. Prohibited uses will never become legally non-conforming even if the County has not enforced the removal of those uses. For questions about land uses and zoning, please contact Mackenzie Johnson at (801)335-8687 or by email at mackenziej@nslcity.org.

BUSINESS LICENSES

The City of North Salt Lake issues business licenses for those businesses who need one. Most home-based businesses are not required to have a NSL business license, but may be granted by request. Licenses are renewed annually on a calendar year, but are also prorated and can be obtained anytime during the year. Businesses within the annexation area for North Salt Lake may continue to use their Davis County business license if they wish until those licenses expire. BUSINESS LICENSES

WHAT TO KNOW:

- Use existing licenses (issued through Davis County) until expiration, then renew with NSL

ANIMALS

The City's animal ordinance allows for up to three dogs without a permit. Four or more dogs requires a kennel license. Visit the City Code (10-10-6) for more details, including information about domestic farm animals, such as chickens.

ANIMALS

WHAT TO KNOW:

- NSL Code allows for up to three (3) dogs without a permit.

Other Helpful City Information

APPEAL AUTHORITY

The City's Hearing Officer hears appeals pertaining to the administration of City Ordinance. Any person, department, board or bureau adversely affected by any decision made in the administration of City Code by the City's administrative staff may appeal the decision to the Hearing Officer.

BURNING REGULATIONS

State regulations prohibit residents from burning wood or coal on NO BURN DAYS. For more information, check their website www.deq.utah.gov and click on See Today's Air Quality Report.

BUILDING INSPECTIONS

All new construction, additions, basement finishes, remodeling, siding, re-roofs, solar panels, water heater and furnace replacements require a building permit and inspection. Inspections are available between 10:00 am and 3:00 pm Monday through Thursday. COMMUNITY GARDEN

Want a garden but don't have room for one? The City has a community garden at the corner of Center Street and Orchard Drive. Beginning in March of each year, interested residents can fill out an [application on the City website](#) or Contact Ali at 801-335-8729 to reserve a plot.

EXTRA GARBAGE PICKUP

The City offers an extra garbage pick up the second (2nd) Saturday of each month from May through November. Place filled containers at the curb Friday night. This service is included in your monthly garbage rate. No piles of trash will be picked up. No toxic or hazardous materials accepted.

FIREWORKS RESTRICTIONS

[Fireworks](#) may be set off on the following holidays, as well as two days prior and one day after each holiday: July 2-5, July 22-25, and December 31 (11 am-1 am Jan. 1). Fireworks are not allowed east of Orchard Drive or south of Eagleridge Drive. Up-to-date information can be found through our local fire district. [South Davis Metro Fire Agency](#)

PARKING TICKETS/CITATIONS

Parking tickets can be paid on our website through Xpress Bill pay. Persons wishing to appeal must do so in writing within 14 calendar days of the notice of violation. An appeal form can be found at <https://www.nslcity.org/600/Appealing-a-Citation>

PARKS TRAILS ARTS AND RECREATION ADVISORY BOARD

This board consists of citizens appointed by the Mayor and City Council to serve two-year terms. They are responsible for reviewing and submitting recommendations on parks, trails, arts, and recreation. This board also participates in planning and volunteering at City activities and celebrations.

PLANNING COMMISSION

The Planning Commission's role is to promote and coordinate comprehensive long-range planning, growth-management, etc. and serves as an advisory board to the City Council on significant development proposals. The commission meets the 2nd and 4th Tuesdays of each month, and appointed residents serve four-year terms.

SENIOR LUNCH BUNCH

The City has a fun group of seniors who meet monthly for lunch, guest speakers, BINGO and more. You can join them the second Wednesday of every month at 11:00 am at City Hall. Watch the [monthly Insider newsletter](#) for updates and scheduled events.

SPRING AND FALL CLEAN UP

Twice per year the City provides a drop-off location for refuse at the Public Works Building, 642 North 400 West. Watch for specific dates in the *Insider* newsletter, on the website or social media. Proof of residency required. [Spring and Fall Clean Up](#)

TREE TRIMMING REQUIREMENTS

Homeowners are required to trim trees in their park strip (above sidewalk and street). [City Code 7-9-6](#) requires that trees, or other growth, must be trimmed fourteen feet (14') above the street and eight feet (8') above the sidewalk.

WATER SERVICE

Annexed properties in the Val Verda area will continue receiving water from their current supplier. There will be no change to water service.

WATERING RESTRICTIONS

Outside watering is prohibited between the hours of 10:00 am and 6:00 pm, and the use of sprinkler irrigation systems is prohibited from October 15 through April 15. (Restrictions may vary depending on local drought conditions, etc.)

WINTER PARKING

[No Parking During Snow Removal/Plowing Hours](#): It is unlawful to park any vehicle or trailer upon the City's paved portion of the street or roadway during a snow event or until snow removal or plowing from pavement edge to pavement edge is complete. Vehicles parked in violation may be cited or impounded and subject to a penalty.

YOUTH CITY COUNCIL



WHAT TO DO NOW TO PREPARE FOR A DISASTER

NOW

1. HAVE A FAMILY PLAN

- Identify a meeting location for all family members to meet.
- Know what your place of employment will do in a disaster.
- Be familiar with school emergency plans.
- If you have an older adult in a care facility, be familiar with the facility's emergency plans.
- Prepare for loved ones with special needs.



2. PUT TOGETHER A SUPPLY KIT

Prepare a disaster kit to sustain you for at least three days (72 hours). It should include:

- battery powered radio
- battery powered flashlight
- extra batteries
- copies of important documents
- first aid kit containing medicines
- extra clothes/blankets
- moist towelettes
- garbage bags
- plastic sheeting
- plastic ties
- can opener
- water
- food
- dust mask
- duct tape
- local maps
- whistle
- towels
- tools
- cash



3. PLAN FOR OBSTACLES

- What if you have no access to emergency responders when you call 911?
- Which neighbors can you contact?
- Do you know who your Neighborhood Coordinator (block captain) is? They have access to resources that may be able to assist you.
- In a disaster the **Area Coordinator** will eventually have access to **District Coordinator** who will have access to the **City Coordinator**. The City will prioritize responses and resources based on District input.

WHAT TO DO DURING A DISASTER

DURING

- **Find safe area** with no gas leaks (shut off meter if leaking)
- **Conserve water** and shut off leaks
- **Text** instead of using voice calls
- Listen to radio or use internet and social media resources for information
- Gather resources and coordinate with Community Emergency Response Teams (CERT)



- **Signal First Responders** (Visible colors in windows):
- **Red=Stop Here**
- **Yellow=Need Assistance**
- **Green=OK for now**



LOCATION. EDUCATION. APPRECIATION.

North Salt Lake is located 10 minutes (7.6 miles) from downtown Salt Lake City. NSL is one of the most well-educated cities in the nation, as 45.72% of adults in the City have at least a bachelor's degree, compared to 21.84% in the average American community. NSL real estate appreciated 57.37% over the last ten years, putting NSL in the top 20% nationally for real estate appreciation.

History of North Salt Lake

Beginning at the boundary line of Salt Lake and Davis counties and stretching east up the mountainside and west towards the Great Salt Lake sits the City of North Salt Lake. On its northern border the city meets Woods Cross and Bountiful.

In 1847 Brigham Young sent settlers north to find pastureland for cattle and to establish settlements. Among these people were the first homesteaders in North Salt Lake. As they left the Salt Lake area and traveled north, they found several steaming hot springs and ponds. These hot springs are still active on the southern boundary of the city. To the west flowed the Jordan River, and the land was swampy and covered with swamp grass. To the east the land slowly climbed up the tall grass-covered lower mountainsides. This grass sometimes hid a deep crevasse large enough to be of danger to cattle. Small natural springs found their way from the mountains into the grassy valley below. Many of the hillsides were rocky and sandy and not well suited for crops or cattle; however, they did produce several sand and gravel excavations.



The first homes built in the area were crude dugouts, which at least offered protection from the winter storms. Later homes were made of adobe, utilizing the natural clay deposits in the area. One of the first settlers of North Salt Lake, John Winegar, built his home of clay from deposits by the Jordan River. Because of the clay deposits, several brickyards were located in the area for a short time.

Animals of all kinds were raised in the area. A family named Schmidt raised pigs; Samuel S. Howard raised cows and in about 1879 began his own dairy, known as "Bountiful Dairy." Holbrook Dairy was later established near the Salt Lake County line and continued until the late 1950s. Products from Bountiful and North Salt Lake dairies were taken into Salt Lake City for sale. Sarah Howard ran a store out of her home, and William Luker created a "Halfway House," a store-restaurant combination where travelers could refresh themselves. The trail along the edge of the hills and above the hot springs turned into a well-traveled road and later became U.S. Highway 89/91.



In 1895 Leary and Warren established a business called Salt Lake Union Stockyards which made cattle important to North Salt Lake. The stockyards were located near the railroad tracks. There was pastureland available and the convenience of the railroad for shipping. Cattle were shipped into the area and either shipped out again or slaughtered for market at one of the area slaughterhouses. In 1916 Cudahy Meat Packing Company bought the Intermountain Ice Packing building on Center Street just below the railroad tracks. It became such a successful meat-packing plant that the street which is now Center Street was called Cudahy Lane. Cattle were shipped in and processed meats were shipped out to destinations all over the world. The plant was closed in 1972.

History (cont.)

In 1930 most local residences and businesses were located below Highway 89/91. About sixty-five homes were on the hillside above. The main source of water was the natural springs that flowed out of the hillside. The area below the highway received water from the privately owned McDuff and McNeil springs located on the hills south on the Salt Lake-Davis County border.



In 1946 a developer purchased land on the hillside to build homes. In order to obtain water for his homes he made a purchase agreement with the owners of the McDuff and McNeil springs. This concerned the landowners below the highway since they were not allowed any additional water from the springs. Because of this concern, some of the citizens formed a committee to draw up a petition to form a town in order that control of the water system could be instigated.

On 3 September 1946 the Davis County Commission granted the area then designated, which was about 456 acres, status as an incorporated town. Chairman Amasa Howard of the county commission appointed Harold R. Howard, Jack Cummings, Alton Boggess, Harold T. Johnson, and David S. Betts as the town board. North Salt Lake took its name from the name of the small post office at the railroad tracks. The old Utah Highway Patrol weigh station was purchased and used as the first town hall. There was only one political party at that time, the North Salt Lake Citizens Party. In 1949 the first election was held, selecting Ray Hatch as mayor of the town.



In 1958 a new municipal building was built on the corner of Main Street and Center Street. This building also housed a fire department for the town. On 1 August 1961 the town of North Salt Lake became a third-class city with a population of 1,655. In 1990, the population was 6,474 and North Salt Lake was just beginning to see future growth in housing and industry.



In 2010, a new City Hall was built immediately south of the old building to meet the needs of the rapidly-growing city. The Veterans Memorial Amphitheater was then constructed where the old building stood.

In 2014, the city changed its name from North Salt Lake City Corporation to the City of North Salt Lake in an attempt to establish a separate identity and location from Salt Lake City.



The City celebrated its 75th anniversary in 2021 as a fourth-class city with an approximate population of 25,000 people. The city now contains residential areas for all income levels, outdoor recreation opportunities, a thriving industrial center that stretches west of Interstate-15 to the Jordan River, and businesses of all kinds have chosen to bring their operations to the City of North Salt Lake.
