9 Tammy Clayton, Chair called the meeting to order at 6:00 p.m.

24 1. WELCOME AND INTRODUCTION

26 2. APPROVAL OF PARKS TRAILS ARTS & RECREATION MINUTES

27
28 The Parks Trails Arts & Recreation minutes of September 27, 2022 were reviewed and approved.

29
30 **Chair Clayton moved to approve the Parks Trails Arts & Recreation meeting minutes of**
31 **September 27, 2022, as written. Board Member Scroger seconded the motion. The motion**
32 **was approved by Board Members Clayton, Thorpe, Scroger, Golden, and Pepin.** Board
33 Member Poulter was not present for the vote.

35 3. PUBLIC WORKS UPDATE

36
37 David Frandsen, Assistant City Manager, presented pictures of signage types currently at the
38 parks. He presented locations of the park signage at Wildrose Park. He also presented a map on
39 the proposed placement of walking trails at Fox Hollow Park and Legacy Park. Mr. Frandsen
40 shared the City had bids on extending the trails and those bids would possibly be taken to City
41 Council meeting next week, November 1, 2022.

45 4. CITY COUNCIL UPDATE

49 5. DISCUSSION OF CITY TRAIL IMPROVEMENTS AND BONNEVILLE
50 SHORELINE TRAIL

52 Board Member Thorpe had previously appointed herself and Board Member Scroger on a
53 subcommittee for signage. She concurred that the current parks and trails signage was consistent
54 and that all should remain in place. She suggested the Bonneville Shoreline Trail signage be
55 incorporated to match the current City signage. Stan Porter, City Council, said that the
56 Bonneville Shoreline Trail has its own signage and any signs in the City cannot duplicate their
57 signage, but must say “connector” to differentiate from the actual trail signs.

59 Linda Horrocks, Communications Coordinator, mentioned the City’s trail signs were peeling and
60 in need of repair. TJ Riley, Parks Superintendent, reminded the Board that per discussion during
61 the last meeting, a trails subcommittee was formed, including Kyle Poulter and Jeff Scroger,
62 board members, along with Kathy Ruggiero, resident, to go along the trails and identify which
63 trail markers needed to be replaced or added. He said once staff had those recommendations,
64 then Public Works would GPS those points and order the signage. Linda Horrocks said once the
65 City had the North Salt Lake signage, then the Bonneville Shoreline Trail signage could be
66 incorporated. Board Member Thorpe said the focus would be on safety, directional, and mile
67 high signage along with the rock signs at the parks. Linda Horrocks asked to join the signage
68 committee.

70 Councilmember Porter said there was verbiage of no horses allowed on the signs now. He shared
71 these signs may have been unofficial and would need to be verified. TJ, Parks Superintendent,
72 said the City had put up some fencing to keep horses out. He also stated horses were not allowed
73 due to the water shed. Councilmember Porter said the reason horses probably should not be
74 allowed was because of the potential of bringing in noxious weeds through their waste. He
75 suggested the Board evaluate which trails should allow horses and take it to the Council to be
76 added to the City’s Code.

77

78 Councilmember Porter introduced Dan Cottam. He mentioned Dan was a surgeon who has a
79 clinic in Salt Lake City and he was also an avid biker. He explained that he and Dan served on a
80 subcommittee for the Bonneville Shoreline Trail together. He noted Dan once served on the
81 Parks, Arts, Trails, and Recreation Board. He stated Dan came up with the flow trail idea, which
82 was steep trails that are built like a roller coaster for bikes. Kyle Poulter, Board Member,
83 confirmed that the mountain biking team used the flow trails.

84

85 Councilmember Porter showed the Board where the Wildrose Trail joined the Bonneville
86 Shoreline Trail on Google Earth. Board Member Poulter said the City did not have good trail
87 connectors. He mentioned the Pipeline Trail in North Salt Lake that joined the Bonneville
88 Shoreline Trail was hardly accessible. Councilmember Porter said that Ali Avery, City Planner,
89 would like to see a trailhead built at Woodbriar and thinks she could get some funding. He

90 explained the Forest Service would need to give the City some land. He indicated the Bonneville
91 Shoreline Trail has been approved to the south radio towers in Salt Lake City. Councilmember
92 Porter shared that Bountiful City was also upset because they also do not have trail access to the
93 Bonneville Shoreline Trail. Kyle Poulter, Board Member, said his biking team will do work as
94 needed to help build trails to get their volunteer hours.

95
96 Dan Cottam shared that Draper adopted their trails and rebuilt them all. He suggested that if the
97 City wanted good trails, it should do the same thing. He indicated the City of North Salt Lake
98 would have to work with the Forest Service to create or improve trails on their land. Mr. Cottam
99 mentioned his willingness to help as needed. He talked about a current National Environmental
100 Policy Act (NEPA) study and said it could be copied and added to. He explained NEPA was a
101 critical law that empowered local communities to protect themselves and their environment from
102 dangerous, rushed or poorly planned federal projects.

119 Board Member Golden provided an update on the photo contest. He was pleased that the City
120 had more entries this year than prior years. He suggested that next year, the City limit the entries
121 to one image per person.

123 c. HALLOWEEN FUN EVENT

125 Chair Clayton said the event would be held on October 29, 2022, at Hatch Park at 9:00 a.m. She
126 asked that the Board Members be there at 8:30 a.m. to set up. She said that five volunteers from
127 the Youth City Council would be there to help. Board Member Scroger said he would bring five
128 tombstones for each station and would check on getting pumpkins. Chair Clayton showed what
129 each station would have which included a bag, fruit snacks, wrist band, candy, and a toy. She
130 mentioned a balloon arch for photo opportunities and a DJ would be available to perform group
131 dances. She planned to order 300 donuts from JJ's to hand out. She noted there would not be a
132 costume contest. She asked that everyone share the event on social media.

148 Mr. Frandsen handed out a rough draft of scheduled events for 2023. He explained the next
149 meeting on November 29, 2022 would be the planning meeting.

151 Board Members asked for a main contact to go through for any questions on events or
152 reimbursement. It was determined Carmen Wilson, Public Works Operations Manager, would be
153 the point of contact for any questions. Dallas Golden was the treasurer for the Board and
154 reimbursement requests should be sent to him.

156 Board Member Golden shared a couple of ideas. He suggested hosting a creativity panel where
157 experts of various fields are invited to come and talk at an event. He also suggested the City host
158 a story telling night where the community was invited to come and tell stories. Linda Horrocks
159 suggested this could be combined with NSL Reads event.
