- Grading plans and activities** must be in accordance with Appendix J, Grading, of the currently adopted edition of the International Building Code.
  
- Site Plan Showing:**
  - Property boundaries and area(s) to be disturbed
  - Existing/Proposed Easements
  - Existing on-site features
  - Existing utilities
  - Identify the use and occupancy for which the proposed work is intended
  
- Grading Plan**
  - Estimate quantities of excavation and fill
  - Existing proposed contour lines
  - Material Storage Sites and disposal areas
  - Soil reports for residential subdivisions and commercial and institutional uses

*A soils report is not required where the City Engineer determines that the nature of the work applied for is such that a report is not necessary.*
  
- Storm Water:**
  - Signed copy of the UPDES Permit (Notice of Intent)
  - Signed copy of the SWPPP (Storm Water Pollution Prevention Plan) will all appendix

- For Fills greater than 8"**, soils reports for fill material must be submitted that include, at minimum:
  - Borrow site
  - Soil classification
  - Compaction information and other characteristic

***\*The City Engineer may waive a part or all of the submittal requirements depending on size of area disturbed, level of impact, slope of existing ground, etc.***

***\*\*The applicant must follow all requirements of the City Code, Part 9-800 Storm Water Management***
